Right of Abode in Ghana

What is the Right of Abode?

The Right of Abode is a legal status that lets eligible people live in Ghana **indefinitely**, **enter without a visa**, and **work without a work permit**. It's granted by the Minister (with Presidential approval) to (1) Ghanaians who lost citizenship after acquiring another nationality, and (2) **persons of African descent in the Diaspora**. Benefits are set out in Sections 17–18 of the Immigration Act, 2000 (Act 573).

Required Documents & Explanations

Important: Application forms are **not published online**; you complete the prescribed form and submit through the **Ghana Immigration Service (GIS)**. The Ministry's page confirms you apply to the Minister and GIS conducts due diligence. (Ghana Interior Ministry)

A. If you are a Ghanaian who lost citizenship (now using a foreign passport) ("Ghanaian descents" in GIS wording)

- 1. Completed application form obtained and filed at GIS. (gis.gov.gh)
- 2. Two (2) passport-size photos recent, identical. (gis.gov.gh)
- Letter of application from you or your sponsor, requesting Right of Abode. (gis.gov.gh)
- 4. **Attestation by two Ghanaians of standing** Notaries Public, Lawyers, or Senior public officers, with copies of their Ghana ID cards. (gis.gov.gh)
- 5. **Passport copies** your **bio-data page** and **current Ghana residence permit** page (if any). (gis.gov.gh)
- 6. **Evidence of immovable property (if applicable)** e.g., indenture, site plan. (gis.gov.gh)
- 7. **Renunciation certificate** as listed by GIS; bring any renunciation evidence relevant to your case. (GIS requirement list includes "Renunciation certificate".) (gis.gov.gh)
- 8. **Autobiography** brief personal profile/history. (gis.gov.gh)
- 9. **Birth certificate** to evidence Ghanaian origin. (gis.gov.gh)
- 10. **Ghana Police Clearance** current report. (gis.gov.gh)
- 11. Non-Citizen Ghana Card copy of your valid card. (gis.gov.gh)

B. If you are a person of African descent in the Diaspora (e.g., African-American)

- 1. Completed application form obtained and filed at GIS. (gis.gov.gh)
- 2. **Application letter** from you or your sponsoring company/organization. (gis.gov.gh)
- 3. Attestation letters from two Ghanaians of repute Notaries/Lawyers/Senior public officers, with Ghana ID copies. (gis.gov.gh)
- 4. **Evidence of contribution to Ghana's development** e.g., monetary value of shares, bank statements, audited accounts, or proof of employing Ghanaians. (*This speaks to Act 573 s.17(3)(d): ability to make a substantial contribution.)* (gis.gov.gh)
- 5. Current Ghana Police Report required. (gis.gov.gh)
- 6. Non-Citizen Ghana Card (copy) required. (gis.gov.gh)

- 7. Company documents (if applying via a company) Companies Code registration, audited accounts (last 3 years), SSNIT returns for Ghanaian employees, and Tax Clearance Certificates (personal & company) for the last 6 years. (gis.gov.gh)
- 8. Medical Report from the Ghana Immigration Service Clinic. (gis.gov.gh)

Legal criteria for Diaspora applicants (Act 573, s.17(3)):

good character (attested by two Ghanaians), no 12-month+ criminal sentence, independent means, capacity to make a substantial contribution to Ghana's development, and at least 18 years of age.

Time Frame

About six (6) months after GIS submits its due-diligence report to the Ministry (per the Ministry's official service page). Actual duration varies by case. (Ghana Interior Ministry)

Fees & Charges

The GIS Fees & Charges schedule lists Right of Abode (historic schedule shows: GH¢1,940 (\$200.00 USD) for "Ghanaians with foreign passport" and GH¢3,879 (\$400.00 USD) for "Other Nationals"). Fees are subject to change; confirm current amounts at GIS before payment. (gis.gov.gh)

Notes to include on your page/PDF

- **Forms** are not downloadable; obtain and file at **GIS HQ** or the designated GIS office handling Right of Abode. (gis.gov.gh, Ghana Interior Ministry)
- The status is **not the same as citizenship**; it grants indefinite residence, visa-free entry, and the right to work **without a work permit** (Act 573 s.18).
- Requirements can vary case-by-case; GIS may request additional evidence.
